RESOLUTION FOR THE CLOSURE OF KIMBROUGH UNITED METHODIST CHURCH Demopolis District – Lack of financial viability

WHEREAS the Kimbrough United Methodist Church (2230), located in Wilcox County, has had a long and proud history but has been declining in membership and attendance for years; and

WHEREAS the district superintendent has recommended closing the Kimbrough United Methodist Church and recommended transfer of membership to the church of their choice; and WHEREAS the consent to close has been granted by the presiding bishop, a majority of district superintendents, and the district board of church location and building, in accordance with Paragraph 2549.2.4.b of the 2016 Book of Discipline; and

WHEREAS Kimbrough United Methodist Church has a reversionary deed;

THEREFORE, BE IT RESOLVED that Kimbrough United Methodist Church be closed effective May 11, 2022, and that all real and personal, tangible and intangible property of Kimbrough United Methodist Church immediately shall vest in the annual conference board of trustees, who shall deed the property to the original donor of the property.
